### PARKING REGULATIONS

1. Driving privileges are reserved for junior and senior students.
2. Students must have earned at least a "C" average during the last grading period and have not had any discipline issues.
3. All automobiles parked on the school grounds must be registered with the school and must display the current permit on the rear view mirror.
4. Parking is strictly limited to the student parking area.
5. To facilitate identification, the permit's number must be facing the front of the car.
6. All students must be licensed and covered by insurance. The school is not responsible for the automobile or its contents.
7. There is no loitering or unauthorized visitation in the parking lot.
8. There will be no speeding on the school grounds over 15 miles per hour, or any form of reckless driving.
9. Vehicles and all containers inside the vehicle by an administrator without individualized reasonable suspicion. The student and the owner of the vehicle shall have no expectation of privacy in any vehicle or in the contents of any vehicle on school property.
10. Parking regulations are strictly enforced. It is considered a privilege to park on school grounds. Suspension of driving privileges, towing of vehicle and/or suspension from school may occur when violations of these regulations occur.
11. Students applying for and receiving permits fully understand their responsibility in following these rules.
12. All driving regulations and laws set by the State of Indiana apply to driving on school grounds unless otherwise noted.
13. Student driving privileges may be revoked for disciplinary issues, poor attendance, or academic performance.
